Background

With the European Green Deal, the EU aims to become climate-neutral by 2050. A significant step towards this goal is the reduction of CO2 emissions. The Carbon Border Adjustment System (CBAM) plays a crucial role in this effort. It was developed to complement the already established European Emissions Trading System, which is considered a central instrument for CO2 reduction.

Since October 1, 2023, we have been in the first phase of the CBAM, which began with the introduction of reporting obligations for EU importers of goods covered by CBAM. These Importers must quarterly create and submit CBAM reports to disclose information about the imported goods and their associated emissions. From 2026 on – start of the second phase – EU importers of goods covered by CBAM will register with national authorities where they required to buy CBAM certificates to cover for the imports' emissions.
